A BILL

To amend the Federal Crop Insurance Act to promote crop insurance support for beginning farmers and ranchers and veteran farmers and ranchers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Crop Insurance for
5 Future Farmers Act”.

1 **SEC. 2. CROP INSURANCE SUPPORT FOR BEGINNING FARM-**
2 **ERS AND RANCHERS AND VETERAN FARMERS**
3 **AND RANCHERS.**

4 (a) DEFINITION OF BEGINNING FARMER OR RANCH-
5 ER.—

6 (1) IN GENERAL.—Section 502(b)(3) of the
7 Federal Crop Insurance Act (7 U.S.C. 1502(b)(3))
8 is amended by striking “5” and inserting “10”.

9 (2) CONFORMING AMENDMENT.—Section
10 522(c)(7) of the Federal Crop Insurance Act (7
11 U.S.C. 1522(c)(7)) is amended by striking subpara-
12 graph (F).

13 (b) DEFINITION OF VETERAN FARMER OR RANCH-
14 ER.—Section 502(b)(14)(B) of the Federal Crop Insur-
15 ance Act (7 U.S.C. 1502(b)(14)(B)) is amended—

16 (1) in clause (ii), by striking “5 years” and in-
17 serting “10 crop years”; and

18 (2) in clause (iii), by striking “5-year” and in-
19 serting “10-year”.

20 (c) INCREASE IN ASSISTANCE.—Section 508(e)(8) of
21 the Federal Crop Insurance Act (7 U.S.C. 1508(e)(8)) is
22 amended—

23 (1) by striking “Notwithstanding” and insert-
24 ing the following:

25 “(A) IN GENERAL.—Notwithstanding”;

1 (2) in subparagraph (A) (as so designated), by
2 striking “is 10 percentage points greater than” and
3 inserting “is the number of percentage points speci-
4 fied in subparagraph (B) greater than”; and

5 (3) by adding at the end the following:

6 “(B) PERCENTAGE POINTS ADJUST-
7 MENTS.—For purposes of subparagraph (A),
8 the percentage points specified in this subpara-
9 graph are as follows:

10 “(i) For each of the first and second
11 reinsurance years that a beginning farmer
12 or rancher or veteran farmer or rancher
13 participates as a beginning farmer or
14 rancher or veteran farmer or rancher, re-
15 spectively, in the applicable policy or plan
16 of insurance, 15 percentage points.

17 “(ii) For the third reinsurance year
18 that a beginning farmer or rancher or vet-
19 eran farmer or rancher participates as a
20 beginning farmer or rancher or veteran
21 farmer or rancher, respectively, in the ap-
22 plicable policy or plan of insurance, 13 per-
23 centage points.

24 “(iii) For the fourth reinsurance year
25 that a beginning farmer or rancher or vet-

1 eran farmer or rancher participates as a
2 beginning farmer or rancher or veteran
3 farmer or rancher, respectively, in the ap-
4 plicable policy or plan of insurance, 11 per-
5 centage points.

6 “(iv) For each of the fifth through
7 tenth reinsurance years that a beginning
8 farmer or rancher or veteran farmer or
9 rancher participates as a beginning farmer
10 or rancher or veteran farmer or rancher,
11 respectively, in the applicable policy or
12 plan of insurance, 10 percentage points.”.
