## A BILL

To require the Administrator of the National Aeronautics and Space Administration to continue modernization efforts with respect to Federal rocket propulsion test infrastructure at National Aeronautics and Space Administration centers.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Building Out Opti-  
5 mized Space Testing for Engines Act” or the “BOOST  
6 for Engines Act”.

1 **SEC. 2. DEFINITIONS.**

2 In this Act:

3 (1) ADMINISTRATOR.—The term “Administrator” means the Administrator of the National  
4 Aeronautics and Space Administration.

5 (2) NASA.—The term “NASA” means the National Aeronautics and Space Administration.

6 **SEC. 3. ROCKET ENGINE TEST INFRASTRUCTURE.**

7 (a) MODERNIZATION PROGRAM.—The Administrator  
8 shall continue to carry out a program to modernize rocket  
9 propulsion test infrastructure at NASA facilities—

10 (1) to increase capabilities;

11 (2) to enhance safety;

12 (3) to support propulsion development and testing;  
13 and

14 (4) to foster the improvement of Government  
15 and commercial space transportation and exploration.

16 (b) PROJECTS.—Projects funded under the program  
17 described in subsection (a) may include—

18 (1) infrastructure and other facilities and systems relating to rocket propulsion test stands and  
19 rocket propulsion testing;

20 (2) enhancements to test facility capacity and  
21 flexibility; and

(3) such other projects as the Administrator considers appropriate to meet the goals described in that subsection.

4       (c) REQUIREMENTS.—In carrying out the program  
5 under subsection (a), the Administrator shall—

(1) prioritize investments in projects that enhance test and flight certification capabilities for large thrust-level atmospheric and altitude engines and engine systems, and multi-engine integrated test capabilities;

11                   (2) continue to make underutilized test facilities  
12                   available for commercial use on a reimbursable  
13                   basis;

18                             (4) ensure that no project carried out under  
19 such program adversely impacts, delays, or defers  
20 testing or other activities associated with facilities  
21 used for Government programs, including—

(A) the Space Launch System and the Exploration Upper Stage of the Space Launch System;

(B) in-space propulsion to support exploration missions; and

3 (C) nuclear propulsion testing.

(d) RULE OF CONSTRUCTION.—Nothing in this section shall preclude a NASA program, including the Space Launch System and the Exploration Upper Stage of the Space Launch System, from using the modernized test infrastructure developed under this section.
