A BILL

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Comprehensive Health
3 and Integrity in Licensing and Documentation Act of
4 2025” or the “CHILD Act of 2025”.

5 **SEC. 2. DEFINING “COVERED INDIVIDUAL” FOR PURPOSES**
6 **OF BACKGROUND CHECKS UNDER THE NA-**
7 **TIONAL CHILD PROTECTION ACT OF 1993.**

8 Section 5(9)(B) of the National Child Protection Act
9 of 1993 (34 U.S.C. 40104(9)(B)) is amended—

10 (1) in clause (i)—

11 (A) by inserting “, contracts with,” after
12 “is employed by”;

13 (B) by inserting “, contract with,” after
14 “be employed by”; and

15 (C) by striking “or” at the end;

16 (2) by redesignating clause (ii) as clause (iii);

17 (3) by inserting after clause (i) the following:

18 “(ii) is employed by or volunteers
19 with, or seeks to be employed by or volun-
20 teer with, an entity that is under contract
21 with a qualified entity;”;

22 (4) in clause (iii), as so redesignated, by adding
23 “or” at the end; and

24 (5) by adding at the end the following:

1 “(iv) is licensed or certified, or seeks
2 to be licensed or certified, by a qualified
3 entity;”.
