AN ACT

To amend title 38, United States Code, to reorganize the acquisition structure of the Department of Veterans Affairs and to establish the Director of Cost Assessment and Program Evaluation in the Department, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 9 (a) Definitions.—Chapter 81 of title 38, United
- 10 States Code, is amended by inserting after subchapter VI
- 11 the following new subchapter:
- 12 "Subchapter VII—Acquisition Organization,
- 13 Cost Assessment, and Program Evaluation
- 14 "SEC. 8181. DEFINITION OF MAJOR ACQUISITION PRO-

- 16 "In this subchapter, the term 'major acquisition pro-
- 17 gram' means a program of the Department to acquire
- 18 services, supplies, technology, systems, or a combination

- 1 thereof, with an estimated total program cost, estimated
- 2 by the Secretary, that exceeds—
- 3 "(1) \$1,000,000,000 (adjusted pursuant to sec-
- 4 tion 1908 of title 41) for the total life cycle cost of
- 5 the program; or
- 6 "(2) \$200,000,000 (adjusted pursuant to sec-
- 7 tion 1908 of title 41) annually.".
- 8 (b) Assistant Secretary for Acquisition.—Sec-
- 9 tion 308 of such title is amended—

- and inserting "eight"; and
- 12 (2) in subsection (b)(10), by striking "Procure-
- ment functions" and inserting "Acquisition func-

- 21 "(c) Deputy Assistant Secretary for Logis-
- 22 TICS.—(1) Pursuant to section 308(d) of this title, the
- 23 Secretary shall appoint a Deputy Assistant Secretary of
- 24 Veterans Affairs for Logistics, who shall report to the As-
- 25 sistant Secretary for Acquisition.

- 1 "(2) The Deputy Assistant Secretary of Veterans Af-
- 2 fairs for Logistics shall be responsible for administration
- 3 of logistics and supply chain operations of the Depart-
- 4 ment.
- 5 "(d) Deputy Assistant Secretary for Procure-
- 6 MENT.—(1) Pursuant to section 308(d) of this title, the
- 7 Secretary shall appoint a Deputy Assistant Secretary of

22	"(A) certified in project management at level
23	three by—
24	"(i) the Department;

21	pursuant to subsection (a) shall be—
22	"(1) certified in project management at level
23	three by—

3	"(C) the Department of Defense pursuant
4	to section 1701a of title 10; or
5	"(2) hold an equivalent certification by a pri-

7	zation, as determined appropriate by the Secretary.
8	"(c) Duties.—Each manager appointed pursuant to
9	subsection (a) for a major acquisition program shall—
10	"(1) report to the Assistant Secretary for Ac-
11	quisition through the Program Executive Officer re-
12	sponsible for the major acquisition program; and
13	"(2) shall be responsible for, with respect to the
14	major acquisition program—
15	"(A) developing, in coordination with the
16	Program Executive Officer, a plan to admin-
17	ister major acquisition program, which shall be
18	known as the 'program baseline' for the major
19	acquisition program, that includes—
20	"(i) a description of each acquisition
21	phase of the major acquisition program;
22	"(ii) for each such acquisition phase,
23	requirements for advancing the major ac-

2	and performance of the major acquisition
3	program that account for the entire life
4	cycle of the major acquisition program;
5	"(B) ensuring the major acquisition pro-
6	gram is in compliance with such requirements
7	and providing all program documentation, in-
8	cluding program baseline documentation, cost,
9	schedule, performance and risk assessments,
10	and other relevant materials, to designated offi-
11	cials and relevant governance boards;
12	"(C) developing resource requests and jus-
13	tifications necessary to satisfy such require-
14	ments; and
15	"(D) on a continuous basis, assessing and
16	managing risks to satisfying the requirements
17	of such program baseline relating to cost and
18	schedule.
19	"(d) Program Decision Authority.—The Sec-
20	retary shall ensure that—
21	"(1) program decision authority for oversight of
22	a major acquisition program is the Assistant Sec-
23	retary for Acquisition; and
24	"(2) program management offices for major ac-
25	quisition programs are independent of the Veterans

1	SEC. 5. INDEPENDENT VERIFICATION AND VALIDATION OF
2	MAJOR ACQUISITION PROGRAMS OF DEPART
3	MENT OF VETERANS AFFAIRS.
4	(a) Contracting Authority.—Not later than 120
5	days after the date of the enactment of this Act, the Sec-
6	retary of Veterans Affairs shall seek to enter into one or
7	more contracts using competitive procedures with one or
8	more entities to carry out the functions described in sub-
9	section (c).
10	(b) Eligibility.—
11	(1) In general.—An entity is not eligible to
12	be awarded a contract under this section unless the
13	Chief Acquisition Officer of the Department of Vet-
14	erans Affairs determines, at the time of evaluation
15	of offers submitted under subsection (a), that the
16	entity is currently performing or has performed, dur-
17	ing the preceding three-year period, not fewer than
18	three prime contracts from either governmental or
19	commercial health care organizations for—
20	(A) the independent verification and vali-
21	dation services or equivalent services, including
22	systems engineering and technical advisory
23	(SETA) support of major acquisition programs;
24	or
25	(B) the independent verification and vali-
26	dation or systems engineering and technical ad-

- visory (SETA) support of the development or acquisition of major acquisition programs or defense systems, in accordance with guidance of the Department of Defense relating to such acquisition programs or such business systems.
 - (2) Past Performance.—For any contract used to demonstrate eligibility under paragraph (1), an entity must have performed the work at a satisfactory or better level as indicated by the past performance information in the Contractor Performance Assessment Reporting System, or successor system.
 - (3) Demonstration of lack of conflict of interest.—The Secretary shall revoke the eligibility of an entity under this subsection if an entity does not demonstrate clear and unmitigable evidence that the entity does not have a conflict of interest with respect to the effective performance of functions under subsection (c).
 - (4) NO MITIGATION PLANS ACCEPTABLE.—The Secretary may not accept from an entity a plan to mitigate a conflict of interest in order to ameliorate any limitation or prohibition under this subsection.
- 23 (c) Functions.—The functions specified in this sub-24 section are the following:

1	(1) The independent verification and validation
2	of each major acquisition program project—
3	(A) when such major acquisition program
4	is initiated, with respect to its design and the
5	development of its requirements and acquisi-
6	tion;
7	(B) at the conclusion of such program; and
8	(C) at any other intervals during such pro-
9	gram selected by the Chief Acquisition Officer
10	of the Department.
11	(2) The independent verification and validation
12	of other programs or projects of the Department se-
13	lected by the Chief Acquisition Officer of the De-
14	partment, at intervals selected by the Chief Acquisi-
15	tion Officer.
16	(d) Funding.—The Chief Financial Officer of the
17	Department shall ensure that each organizational subdivi-
18	sion of the Department that enters into a contract under
19	subsection (a) proportionally contributes amounts to fund
20	each such contract.
21	(e) Independent Verification Validation De-
22	FINED.—The term "independent verification and valida-
23	tion" means a comprehensive inspection, a review, anal-
24	ysis, and testing, or an assessment of systems, software,

1	or hardware, as applicable, performed by an entity award-
2	ed a contract under subsection (a)—
3	(1) to verify that the requirements of a pro-
4	gram, project or system, or a development phase of
5	such a program or project, are correctly defined; and
6	(2) to validate cost, schedule, and performance
7	baselines of current programs and measure program
8	effectiveness.
9	SEC. 6. DEPARTMENT OF VETERANS AFFAIRS COST AS
10	SESSMENT AND PROGRAM EVALUATION.
11	(a) In General.—Subchapter VI of chapter 81 of
12	title 38, United States Code, as added by section 2 and
13	amended by section 3, is further amended by adding at
14	the end the following new section:
15	"§ 8184. Cost assessment and program evaluation
16	"(a) Director of Cost Assessment and Pro-
17	GRAM EVALUATION.—There is in the Department a Direc-
18	tor of Cost Assessment and Program Evaluation, who
19	shall report directly to the Secretary.
20	"(b) Responsibilities.—The responsibilities of the
21	Director are as follows:
22	"(1) To develop policies and procedures for cost
23	estimation and analysis of major acquisition pro-
24	grams of the Department.

- "(2) To conduct independent cost estimates and analyses for major acquisition programs to support acquisition decisions, or any other acquisitions as directed by the Secretary,
 - "(3) To provide an independent cost estimate to the Assistant Secretary for Acquisition in advance of a decision to proceed with full-scale acquisition for a major acquisition program or any other program as directed by the Director.
 - "(4) To evaluate the effectiveness of major acquisition programs in meeting Department objectives.
 - "(5) Not less frequently than once each year, to submit to the Secretary and the Committee on Veterans' Affairs of the Senate and the Committee on Veterans' Affairs of the House of Representatives an annual report on cost estimation and program evaluation activities, including recommendations to improve acquisition efficiency. Such report shall include a list of all acquisitions where the independent cost estimate for a major acquisition program exceeded the budget request for the program by more than 5 percent.
- 24 "(c) SUPPORT AND RESOURCES.—The Chief Finan-25 cial Officer of the Department shall provide to the Sec-

- 1 retary such support and resources as may be necessary
- 2 for the Secretary to ensure the effective establishment and
- 3 functioning of the Director of Cost Assessment and Pro-
- 4 gram Evaluation.".
- 5 (b) Report on Monitoring of Operating and
- 6 Support Costs for Major Acquisition Programs.—
- 7 (1) Report to secretary of veterans af-
- 8 FAIRS.—Not later than one year after the date of
- 9 the enactment of this Act, and not less frequently
- than once each year thereafter until December 31,
- 11 2028, the Director of Cost Assessment and Program
- 12 Evaluation of the Department of Veterans Affairs
- shall submit to the Secretary of Veterans Affairs a
- report on systems and methods for tracking and as-
- sessing operating and support costs of major acqui-

- 20 (2) Transmittal to congress.—Not later
- 21 than 30 days after receiving a report pursuant to

- 25 Representatives the report received by the Secretary.

1	SEC. 7. IMPROVEMENTS TO HIRING OF ENTRY-LEVEL AC-
2	QUISITION POSITIONS IN DEPARTMENT OF
3	VETERANS AFFAIRS.
4	(a) Priority Use of Internship Programs for
5	HIRING INTO ENTRY-LEVEL POSITIONS IN ACQUISI-
6	TIONS.—The Secretary of Veterans Affairs shall prioritize
7	the use of acquisition internship programs to hire employ-
8	ees to entry-level positions relating to acquisition in the
9	Department of Veterans Affairs.
10	(b) Annual Number of Participants in Acquisi-
11	TION INTERNSHIP PROGRAMS.—
12	(1) IN GENERAL.—Not later than September
13	30 of the first fiscal year beginning after the date
14	of the enactment of this Act, the Secretary shall
15	take such actions as may be necessary to ensure that
16	the annual number of participants in acquisition in-
17	ternship programs of the Department is—
18	(A) not fewer than twice the number of
19	participants in such programs during fiscal year
20	2025; and
21	(B) not more than 4 times the number of
22	participants in such programs during such fis-
23	cal year.
24	(2) Termination.—The requirements of para-
25	graph (1) shall terminate on the date on which the
26	Secretary certifies to the appropriate committees of

1 Congress that the projected number of graduates of 2 acquisition internship programs is sufficient to sat-3 isfy the human capital needs of the Department with 4 respect to acquisition, taking into account the rate

of attrition and projected retirements of personnel.

- 6 (3) APPROPRIATE COMMITTEES OF CONGRESS
 7 DEFINED.—In this subsection, the term "appro8 priate committees of Congress" means the Com9 mittee on Veterans' Affairs of the Senate and the
 10 Committee on Veterans' Affairs of the House of
 11 Representatives.
- 12 SEC. 8. INDEPENDENT ANALYSIS OF ACQUISITION PROC-
- 13 ESS OF DEPARTMENT OF VETERANS AF-14 FAIRS.
- 15 (a) Systems Engineering Analysis.—Not later 16 than one year after the date of the enactment of this Act,
- 17 the Secretary of Veterans' Affairs shall seek to enter into
- 18 a memorandum of understanding with the acquisition re-
- 19 search center established under section 4142(a) of title 10,
- 20 United States Code, to conduct a systems engineering
- 21 analysis of the acquisition process of the Department of
- 22 Veterans Affairs.

- 23 (b) Report.—Not later than one year after the date
- 24 in which the Secretary enters into the memorandum of
- 25 understanding required by subsection (a), the Secretary

- 1 shall submit to Committee on Veterans' Affairs of the Sen-
- 2 ate and the Committee on Veterans' Affairs of the House
- 3 of Representatives a report on the findings of the acquisi-
- 4 tion research center with respect to the analysis conducted
- 5 under such subsection.

6 SEC. 9. REQUIREMENTS DEVELOPMENT PROCESS.

- 7 (a) In General.—Subchapter VI of chapter 81 of
- 8 title 38, United States Code, as added by section 2 and
- 9 amended by sections 3 and 6, is further amended by add-
- 10 ing at the end the following new section:

11 "SEC. 8185. REQUIREMENTS DEVELOPMENT PROCESS.

- 12 "(a) Establishment of Process.—(1) The Sec-
- 13 retary shall establish a standardized requirements develop-
- 14 ment process for major acquisition programs.
- 15 "(2) The process established pursuant to paragraph
- 16 (1) shall—
- 17 "(A) define and validate mission-driven require-
- ments for major acquisition programs exceeding
- 19 \$200,000,000 annually or \$1,000,000,000 in
- 20 lifecycle costs, in coordination with the Assistant
- 21 Secretary for Acquisition;
- 22 "(B) incorporate data-driven needs assess-
- 23 ments, stakeholder input from relevant administra-
- tions, staff offices, and other elements of the De-
- 25 partment and veterans service organizations, and

- 1 alignment with statutory mandates, such as section
- 2 8121 of this title; and
- 3 "(C) ensure iterative validation of requirements
- 4 through independent verification and validation, as
- 5 described in section 8185 of this title, to confirm
- 6 cost, schedule, and performance baselines.
- 7 "(b) Limitation on Personnel.—The Secretary
- 8 shall implement the process established pursuant to sub-
- 9 section (a) using staff within the Office of Acquisition and
- 10 other relevant offices of the Department, as established
- 11 under section 8182 of this title, without creating new posi-
- 12 tions, unless a subsequent cost-benefit analysis, validated
- 13 by the Director of Cost Assessment and Program Evalua-
- 14 tion, justifies additional resources.".
- 15 (b) Report.—Not later than 180 days after the date
- 16 of the enactment of this Act, the Secretary shall submit
- 17 to the Committee on Veterans' Affairs of the Senate and
- 18 the Committee on Veterans' Affairs of the House of Rep-
- 19 resentatives a report detailing the process established pur-
- 20 suant to section 8185 of such title, as added by subsection
- 21 (a), and a plan for implementation of such process, includ-
- 22 ing timelines for integration with major acquisition pro-
- 23 gram baselines.

1 SEC. 10. CONFORMING AMENDMENTS.
