2	This Act may be cited as the "Critical Infrastructure						
3	Manufacturing Feasibility Act".						
4	SEC. 2. STUDY ON CRITICAL INFRASTRUCTURE MANUFAC						
5	TURING IN THE UNITED STATES.						
6	(a) Definition of Critical Infrastructure						
7	Sector.—In this section, the term "critical infrastructure						
8	s sector" means each of the 16 designated critical infra						
9	structure sectors identified in Presidential Policy Directive						
0	21 of February 12, 2013 entitled "Critical Infrastructure						
1	Security and Resilience".						
2	(b) STUDY.—Not later than 1 year after the date of						
3	enactment of this Act, the Secretary of Commerce shall						
4	conduct a study to—						
5	(1) identify, within each critical infrastructure						
6	sector, any product—						
7	(A) necessary for the construction, mainte-						
8	nance, operation, or restoration of the critical						
9	infrastructure sector; and						
20	(B) that is in high demand and is being						
21	imported due to a manufacturing, material, or						
22	supply chain constraint in the United States;						
23	(2) analyze the costs and benefits of manufac-						
24	turing in the United States any product identified						

under paragraph (1), including any effects on—

1	(A) jobs, employment rates, and labor con-
2	ditions in the United States; and
3	(B) the cost of the product;
4	(3) identify any product identified under para-
5	graph (1) that feasibly may be manufactured in the
6	United States;
7	(4) analyze the feasibility of, and any impedi-
8	ments to, manufacturing any product identified
9	under paragraph (3) in—
10	(A) a rural area;
11	(B) an industrial park; or
12	(C) an industrial park in a rural area; and
13	(5) identify any Federal policies, regulations, or
14	guidance in effect that may inhibit, create barriers
15	to, or increase the cost of manufacturing a product
16	identified under paragraph (1) in the United States.
17	(e) Report to Congress.—Not later than 18
18	months after the date of the enactment of this Act, the
19	Secretary of Commerce shall—
20	(1) submit to Congress an unclassified report,
21	which may include a classified annex, containing the
22	results of the study required by subsection (b), with
23	recommendations relating to manufacturing in the
24	United States products identified under subsection
25	(b)(3); and

1	(2) make the unclassified report available to the
2	public on the website of the Department of Com-
3	merce.
