A BILL

To amend title XVIII of the Social Security Act to provide for the continued designation of hospitals that met mountainous terrain or secondary roads distance requirement as critical access hospitals and to modify distance requirements for ambulance services furnished by critical access hospitals.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Preserving Emergency
5 Access in Key Sites Act” or the “PEAKS Act”.

1 **SEC. 2. TREATMENT OF HOSPITALS THAT MET MOUN-**
 2 **TAINOUS TERRAIN OR SECONDARY ROADS**
 3 **DISTANCE REQUIREMENT FOR DESIGNATION**
 4 **AS CRITICAL ACCESS HOSPITAL.**

5 Section 1820(h) of the Social Security Act (42 U.S.C.
 6 1395i–4(h)) is amended by adding at the end the following
 7 new paragraph:

8 “(4) TREATMENT OF HOSPITALS THAT MET
 9 MOUNTAINOUS TERRAIN OR SECONDARY ROADS DIS-
 10 TANCE REQUIREMENT FOR DESIGNATION.—

11 “(A) IN GENERAL.—In the case of a hos-
 12 pital described in subparagraph (B), the hos-
 13 pital shall be deemed to meet the 15-mile dis-
 14 tance requirement for mountainous terrain or
 15 secondary roads described in subsection
 16 (c)(2)(B)(i)(I) on or after January 1, 2026.

17 “(B) HOSPITAL DESCRIBED.—A hospital
 18 described in this subparagraph is a hospital
 19 that—

20 “(i) as of the date of enactment of
 21 this paragraph, is designated as a critical
 22 access hospital;

23 “(ii) demonstrates (in a manner deter-
 24 mined by the Secretary) that the hospital
 25 met the 15-mile distance requirement for
 26 mountainous terrain or secondary roads

1 described in subsection (c)(2)(B)(i)(I) as of
 2 the hospital's last certification as a critical
 3 access hospital; and

4 “(iii) after such date of enactment,
 5 has a new hospital or other facility de-
 6 scribed in this subsection located within
 7 10–15 miles of the hospital.

8 “(C) REGULATIONS.—Not later than 1
 9 year after the date of enactment of this para-
 10 graph, the Secretary shall promulgate regula-
 11 tions to carry out this paragraph.”.

12 **SEC. 3. MODIFICATION OF DISTANCE REQUIREMENTS FOR**
 13 **AMBULANCE SERVICES FURNISHED BY CRIT-**
 14 **ICAL ACCESS HOSPITALS.**

15 Section 1834(l)(8) of the Social Security Act (42
 16 U.S.C. 1395m(l)(8)) is amended, in the flush matter fol-
 17 lowing subparagraph (B), by inserting “(or, for such serv-
 18 ices furnished on or after January 1, 2026, in the case
 19 of mountainous terrain or in areas with only secondary
 20 roads available, a 15-mile drive)” after “35-mile drive”.
