Mr. JOHNSON (for himself, Mr. BARRASSO, Mr. BUDD, Mr. CRAMER, Mr. CRAPO, Mr. GRASSLEY, Mr. HAGERTY, Mr. HOEVEN, Mr. LANKFORD, Mr. LEE, Mr. PAUL, Mr. RISCH, Mr. SCOTT of Florida, Mr. TILLIS, and Mr. TUBERVILLE) introduced the following bill; which was read twice and referred to the Committee on Foreign Relations

A BILL

To require any convention, agreement, or other international instrument on pandemic prevention, preparedness, and response reached by the World Health Assembly to be subject to Senate ratification.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the “No WHO Pandemic
5 Preparedness Treaty Without Senate Approval Act”.

6 SEC. 2. FINDINGS.

7 Congress makes the following findings:

1 (1) On May 18, 2020, President Donald Trump
2 sent a letter to World Health Organization (referred
3 to in this Act as “WHO”) Director-General Tedros
4 Adhanom Ghebreyesus (referred to in this Act as the
5 “Director-General”), announcing that—

6 (A) United States contributions to WHO
7 would be halted due its mismanagement of the
8 COVID–19 outbreak and its lack of independence
9 from the People’s Republic of China; and

10 (B) the United States would withdraw
11 from WHO if it did not commit to substantive
12 improvements within 30 days.

13 (2) President Trump’s May 18 letter cited numerous
14 instances of WHO mismanagement of the
15 COVID–19 pandemic, including—

16 (A) unjustified delays informing member
17 states about a potentially serious disease outbreak
18 in Wuhan, China; and

19 (B) repeated grossly inaccurate or misleading
20 claims about the transmissibility of the virus
21 and about the Government of China’s handling of the outbreak.

23 (3) On June 30, 2020, Secretary of State Mike
24 Pompeo formally notified the United Nations of the
25 United States decision to withdraw from WHO,

1 which would have taken effect on July 6, 2021,
2 under the terms of a joint resolution adopted by
3 Congress on June 14, 1948 (Public Law 80–643; 62
4 Stat. 441).

5 (4) A Pew Research Center survey conducted in
6 April and May 2020 indicated that 51 percent of
7 Americans felt that WHO had done a poor or fair
8 job in managing the COVID–19 pandemic.

9 (5) On January 20, 2021, President Joseph
10 Biden sent United Nations Director-General António
11 Guterres a letter retracting the United States notice
12 of withdrawal from WHO.

13 (6) On December 1, 2021, at the second special
14 session of the World Health Assembly (referred to in
15 this Act as the “WHA”) decided—

16 (A) to establish an intergovernmental ne-
17 gotiating body (referred to in this section as the
18 “INB”) to draft and negotiate a WHO conven-
19 tion (referred to in this section as the “Conven-
20 tion”), agreement, or other international instru-
21 ment on pandemic prevention, preparedness,
22 and response, with a view to adoption under Ar-
23 ticle 19 or any other provision of the WHO
24 Constitution; and

(B) that the INB shall submit a progress report to the Seventy-sixth WHA and a working draft of the convention for consideration by the Seventy-seventh WHA.

(A) Building national, regional, and global capacities based on a whole-of-government and whole-of-society approach.

(B) Establishing global access and benefit sharing for all pathogens, and determining a global policy for the equitable production and distribution of countermeasures.

(C) Establishing robust systems and tools
for pandemic preparedness and response.

23 (E) Empowering WHO to fulfill its man-
24 date as the directing and coordinating authority

1 on international health work, including for pan-
2 demic preparedness and response.

3 (8) The INB failed to negotiate an agreement
4 on Convention text and did not present a final draft
5 of the Convention during the Seventy-seventh World
6 Health Assembly held between May 27 and June 1,
7 2024.

8 (9) On June 1, 2024, the World Health Assem-
9 bly extended the INB's Convention mandate until
10 the Seventy-eighth World Health Assembly in 2025.

11 (10) On January 20, 2025, President Donald
12 Trump revoked President Joseph Biden's January
13 25, 2021, retraction of the United States notifica-
14 tion of withdrawal from the WHO.

15 (11) On May 20, 2025, during the 78th World
16 Health Assembly, WHO member states adopted the
17 INB's draft of a WHO Pandemic Agreement.

18 (12) Section 723.3 of title 11 of the Depart-
19 ment of State's Foreign Affairs Manual states that
20 when "determining whether any international agree-
21 ment should be brought into force as a treaty or as
22 an international agreement other than a treaty, the
23 utmost care is to be exercised to avoid any invasion
24 or compromise of the constitutional powers of the
25 President, the Senate, and the Congress as a whole"

1 and includes the following criteria to be considered
2 when determining whether an international agree-
3 ment should take the form of a treaty or an execu-
4 tive agreement:

5 (A) “The extent to which the agreement
6 involves commitments or risks affecting the na-
7 tion as a whole”.

8 (B) “Whether the agreement is intended to
9 affect state laws”.

10 (C) “Whether the agreement can be given
11 effect without the enactment of subsequent leg-
12 islation by the Congress”.

13 (D) “Past U.S. practice as to similar
14 agreements”.

15 (E) “The preference of the Congress as to
16 a particular type of agreement”.

17 (F) “The degree of formality desired for
18 an agreement”.

19 (G) “The proposed duration of the agree-
20 ment, the need for prompt conclusion of an
21 agreement, and the desirability of concluding a
22 routine or short-term agreement”.

23 (H) “The general international practice as
24 to similar agreements”.

1 **SEC. 3. SENSE OF THE SENATE.**

2 It is the sense of the Senate that—

3 (1) a significant segment of the American pub-
4 lic is deeply skeptical of the World Health Organiza-
5 tion, its leadership, and its independence from the
6 pernicious political influence of certain member
7 states, including the People's Republic of China;

8 (2) the Senate strongly prefers that any agree-
9 ment related to pandemic prevention, preparedness,
10 and response adopted by the World Health Assembly
11 pursuant to the work of the INB be considered a
12 treaty requiring the advice and consent of the Sen-
13 ate, with two-thirds of Senators concurring;

14 (3) the scope of the agreement which the INB
15 has been tasked with drafting, as outlined by the Di-
16 rector-General, is so broad that any application of
17 the factors referred to in section 2(11) will weigh
18 strongly in favor of it being considered a treaty; and

19 (4) given the level of public distrust, any rel-
20 evant new agreement by the World Health Assembly
21 which cannot garner the two-thirds vote needed for
22 Senate approval should not be agreed to or imple-
23 mented by the United States.

1 **SEC. 4. ANY WORLD HEALTH ASSEMBLY CONVENTION OR**
2 **AGREEMENT OR OTHER INTERNATIONAL IN-**
3 **STRUMENT RESULTING FROM THE INTER-**
4 **NATIONAL NEGOTIATING BODY'S FINAL RE-**
5 **PORT DEEMED TO BE A TREATY SUBJECT TO**
6 **ADVICE AND CONSENT OF THE SENATE.**

7 Notwithstanding any other provision of law, any con-
8 vention, agreement, or other international instrument on
9 pandemic prevention, preparedness, and response reached
10 by the World Health Assembly pursuant to the rec-
11 ommendations, report, or work of the International Nego-
12 tiating Body established by the second special session of
13 the World Health Assembly is deemed to be a treaty that
14 is subject to the requirements of article II, section 2,
15 clause 2 of the Constitution of the United States, which
16 requires the advice and consent of the Senate, with two-
17 thirds of Senators concurring.
