A BILL

To amend title 10, United States Code, to prohibit discrimination in the Armed Forces on the basis of gender identity, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fit to Serve Act”.

1 **SEC. 2. PROHIBITION ON DISCRIMINATION IN THE ARMED**
 2 **FORCES ON THE BASIS OF GENDER IDEN-**
 3 **TITY.**

4 Chapter 49 of title 10, United States Code, is amend-
 5 ed by inserting after section 974 the following new section:

6 **“§ 975. Prohibition on discrimination on the basis of**
 7 **gender identity**

8 “(a) PROHIBITION.—The Secretary concerned may
 9 not, on the basis of gender identity (including a diagnosis
 10 or potential diagnosis of gender dysphoria)—

11 “(1) prescribe a qualification for service as a
 12 member of the Armed Forces;

13 “(2) involuntarily separate a member of the
 14 Armed Forces;

15 “(3) deny medically necessary health care cov-
 16 erage to a member of the Armed Forces;

17 “(4) require an individual to serve as a member
 18 of the Armed Forces in the sex assigned at birth to
 19 the member;

20 “(5) deny accession, reenlistment, or continu-
 21 ation of service as a member of the Armed Forces;
 22 or

23 “(6) otherwise discriminate against a member
 24 of the Armed Forces.

25 “(b) GENDER IDENTITY DEFINED.—In this section,
 26 the term ‘gender identity’ means the gender-related iden-

1 tity, appearance, mannerisms, or other gender-related
2 characteristics of an individual, regardless of the individ-
3 ual's designated sex at birth.”.
