A BILL

To amend the Taiwan Allies International Protection and Enhancement Initiative (TAIPEI) Act of 2019 to provide that the United States, in its role as a member of any international organizations, should oppose any attempts by the People's Republic of China to resolve Taiwan's status by distorting the decisions, language, policies, or procedures of any such organization, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Taiwan International
5 Solidarity Act”.

6 **SEC. 2. CLARIFICATION REGARDING UNITED NATIONS GEN-**
7 **ERAL ASSEMBLY RESOLUTION 2758 (XXVI).**

8 Section 2(a) of the Taiwan Allies International Pro-
9 tection and Enhancement Initiative (TAIPEI) Act of 2019
10 (Public Law 116–135) is amended—

11 (1) in the matter preceding paragraph (1), by
12 striking “(a) FINDINGS.—”; and

13 (2) by adding at the end the following:

14 “(10) United Nations General Assembly Reso-
15 lution 2758 (XXVI) established the representatives
16 of the Government of the People’s Republic of China
17 as the only lawful representatives of China to the
18 United Nations. The resolution did not address the
19 issue of representation of Taiwan and its people in
20 the United Nations or any related organizations, nor
21 did the resolution take a position on the relationship
22 between the People’s Republic of China and Taiwan
23 or include any statement pertaining to Taiwan’s sov-
24 ereignty.

1 “(11) The United States opposes any initiative
2 that seeks to change Taiwan’s status without the
3 consent of the people of Taiwan.”.

4 **SEC. 3. UNITED STATES ADVOCACY FOR INTERNATIONAL**
5 **ORGANIZATIONS TO RESIST THE PEOPLE’S**
6 **REPUBLIC OF CHINA’S EFFORTS TO DISTORT**
7 **THE “ONE CHINA” POSITION.**

8 Section 4 of the Taiwan Allies International Protec-
9 tion and Enhancement Initiative (TAIPEI) Act of 2019
10 is amended—

11 (1) in paragraph (2), by striking “and” at the
12 end;

13 (2) in paragraph (3), by striking the period at
14 the end and inserting “; and”; and

15 (3) by adding at the end the following:

16 “(4) to instruct, as appropriate, representatives
17 of the United States Government in all organizations
18 described in paragraph (1) to use the voice, vote,
19 and influence of the United States to advocate that
20 such organizations resist the People’s Republic of
21 China’s efforts to distort the decisions, language,
22 policies, or procedures of such organizations regard-
23 ing Taiwan.”.

1 **SEC. 4. OPPOSING THE PEOPLE'S REPUBLIC OF CHINA'S**
2 **EFFORTS TO UNDERMINE TAIWAN'S TIES AND**
3 **PARTNERSHIPS INTERNATIONALLY.**

4 Section 5(a) of the Taiwan Allies International Pro-
5 tection and Enhancement Initiative (TAIPEI) Act of 2019
6 is amended—

7 (1) in paragraph (2), by striking “and” at the
8 end;

9 (2) in paragraph (3), by striking the period at
10 the end and inserting “; and”; and

11 (3) by adding at the end the following:

12 “(4) encourage, as appropriate, United States
13 allies and partners to oppose the People’s Republic
14 of China’s efforts to undermine Taiwan’s official
15 diplomatic relationships and its partnerships with
16 countries with which it does not maintain diplomatic
17 relations.”.

18 **SEC. 5. REPORT ON THE PEOPLE'S REPUBLIC OF CHINA'S**
19 **ATTEMPTS TO PROMOTE ITS “ONE CHINA”**
20 **POSITION.**

21 (a) IN GENERAL.—Section 5(b) of the Taiwan Allies
22 International Protection and Enhancement Initiative
23 (TAIPEI) Act of 2019 is amended by inserting before the
24 period at the end the following: “and information relating
25 to any prior or ongoing attempts by the People’s Republic
26 of China to undermine Taiwan’s membership or observer

1 status in all organizations described in section 4(1) and
2 Taiwan’s ties and relationships with other countries in ac-
3 cordance with subsection (a)’’.

4 (b) EFFECTIVE DATE.—The amendment made by
5 subsection (a) shall—

6 (1) take effect on the date of the enactment of
7 this Act; and

8 (2) apply beginning with the first report re-
9 quired after such date under section 5(b) of the Tai-
10 wan Allies International Protection and Enhance-
11 ment Initiative (TAIPEI) Act of 2019, as amended
12 by subsection (a).
