**A BILL**

To amend the Digital Coast Act to improve the acquisition, integration, and accessibility of data of the Digital Coast program and to extend the program.

1 **SECTION 1. ACQUISITION, INTEGRATION, AND ACCESSI-**

4 Section 4 of the Digital Coast Act (16 U.S.C. 1467)  
 5 is amended—

6 (1) in subsection (b)(1), by inserting “and fully  
 7 and freely available” after “readily accessible”;

8 (2) in subsection (d)(3)(D), by inserting “, in-  
 9 cluding data related to underground infrastructure  
 10 and subsurface utilities” after “data”; and

11 (3) in subsection (g), by striking “2025” and  
 12 inserting “2030”.

13 **SECTION 1. ACQUISITION, INTEGRATION, AND ACCESSI-**  
 14 **BILITY OF DATA OF DIGITAL COAST PRO-**  
 15 **GRAM.**

16 Section 4 of the Digital Coast Act (16 U.S.C. 1467)  
 17 is amended—

18 (1) in subsection (b)(1), by inserting “and fully  
 19 and freely available” after “readily accessible”;

20 (2) in subsection (d)—

21 (A) in paragraph (3)—

22 (i) in subparagraph (D), by inserting  
 23 “, including data related to underground  
 24 infrastructure and subsurface utilities”  
 25 after “data”; and

1                   (ii) in subparagraph (H), by striking  
2                   “and”;

3                   (B) in paragraph (4), by striking the period  
4                   at the end and inserting “; and”; and

5                   (C) by adding at the end the following:

6                   “(5) limit trainings to technical instruction in  
7                   the use of data and tools provided under this sec-  
8                   tion.”; and

9                   (3) in subsection (g), by striking “2025” and in-  
10                  serting “2030”.
