## A BILL

To revoke the visas of, and impose visa restrictions on, certain individuals located in the United States and abroad who are associated with regimes in Venezuela, Cuba, Nicaragua, and Bolivia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Relief for Allies  
5 of Dictators Act of 2026”.

1 **SEC. 2. VISA RESTRICTIONS FOR CERTAIN VENEZUELAN,**  
2 **CUBANS, NICARAGUANS, AND BOLIVIANS.**

3 (a) IN GENERAL.—The Secretary of State shall re-  
4 voke the visa of, or impose visa restrictions on, any indi-  
5 vidual described in subsection (b) who the Secretary deter-  
6 mines—

7 (1)(A) is responsible for, is complicit in, is re-  
8 sponsible for ordering, controlling, or otherwise di-  
9 recting, or is knowingly—

10 (i) committing human rights violations at  
11 any time in Venezuela, Cuba, Nicaragua, or Bo-  
12 livia; or

13 (ii) participating in (directly or indirectly)  
14 any activity in or in relation to Venezuela,  
15 Cuba, Nicaragua, or Bolivia at any time that  
16 undermines or threatens the integrity of the de-  
17 mocracy or sovereignty of, the people of Cuba,  
18 Venezuela, Nicaragua, or Bolivia; or

19 (B) is the spouse or child of a foreign person  
20 described in subparagraph (A); or

21 (2)(A) is described in or identified under—

22 (i) section 804(b) of the Foreign Narcotics  
23 Kingpin Designation Act (21 U.S.C. 1903(b));

24 (ii) Executive Order 13850 (83 Fed. Reg.  
25 55243; relating to blocking property of addi-

1            tional persons contributing to the situation in  
 2            Venezuela); or

3            (iii) Executive Order 13884 (84 Fed. Reg.  
 4            38843; relating to blocking property of the Gov-  
 5            ernment of Venezuela); or

6            (B) is the spouse or child of a foreign person  
 7            described in subparagraph (A).

8            (b) INDIVIDUAL DESCRIBED.—An individual de-  
 9            scribed in this subsection is any foreign person, located  
 10          in the United States or abroad, who—

11            (1) with respect to Venezuela, is—

12            (A) a former official of the Hugo Chavez  
 13            regime; or

14            (B) a current or former official of the  
 15            Nicolas Maduro regime;

16            (2) with respect to Cuba, is—

17            (A) a former official of the Fidel Castro or  
 18            Raul Castro regime; or

19            (B) a current or former official of the  
 20            Miguel Diaz-Canel regime;

21            (3) with respect to Nicaragua, is—

22            (A) a current or former official of the Dan-  
 23            iel Ortega regime; or

24            (B) a Sandinista party member;

1 (4) with respect to Bolivia, is a former official  
2 of the Evo Morales regime;

3 (5) acts on behalf of a regime or party de-  
4 scribed in any of paragraphs (1) through (4);

5 (6) aids in repression by such regime or party;  
6 or

7 (7) assists such regime or party.

8 (c) VISA RESTRICTIONS DESCRIBED.—

9 (1) EXCLUSION FROM THE UNITED STATES  
10 AND REVOCATION OF VISA OR OTHER DOCUMENTA-  
11 TION.—An individual described in subsection (b)—

12 (A) is inadmissible to the United States;

13 (B) is ineligible to receive a visa or other  
14 documentation authorizing entry into the  
15 United States;

16 (C) is otherwise ineligible to be admitted or  
17 paroled into the United States or to receive any  
18 benefit under the Immigration and Nationality  
19 Act (8 U.S.C. 1101 et seq.); and

20 (D) shall—

21 (i) in accordance with section 221(i)  
22 of the Immigration and Nationality Act (8  
23 U.S.C. 1201(i)), have his or her visa or  
24 other documentation revoked, regardless of

1                   when the visa or other documentation was  
2                   issued; and

3                   (ii) be subject to expedited removal.

4                   (2) APPLICABILITY FOR INDIVIDUALS VISITING  
5                   UNITED NATIONS HEADQUARTERS.—In the case of  
6                   an individual described in subsection (b) who intends  
7                   to travel to the United States to visit the head-  
8                   quarters of the United Nations, the Secretary of  
9                   State, in consultation with the Director of National  
10                  Intelligence, the Attorney General, and the Secretary  
11                  of Homeland Security, shall make a case-by-case de-  
12                  termination with respect to the applicability of sub-  
13                  section (a) to such individual.

14                  (d) RULEMAKING.—The President shall issue such  
15                  regulations, licenses, and orders as may be necessary to  
16                  carry out this section.
