To require the Secretary of Commerce to produce a report that provides recommendations to improve the effectiveness, efficiency, and impact of Department of Commerce programs related to supply chain resilience and manufacturing and industrial innovation, and for other purposes.

3	SECTION 1. SHORT TITLE.					
4	This Act may be cited as the "Strengthening Support					
5	for American Manufacturing Act".					
6	SEC. 2. DEFINITIONS.					
7	In this Act:					
8	(1) Appropriate committees of con-					
9	GRESS.—The term "appropriate committees of Con-					
10	gress" means—					
11	(A) the Committee on Commerce, Science					
12	and Transportation of the Senate; and					
13	(B) the Committee on Energy and Com-					
14	merce of the House of Representatives.					
15	(2) COVERED OFFICES AND BUREAUS.—Th					
16	term "covered offices and bureaus" means offices					
17	and bureaus of the Department of Commerce identi-					
18	fied under section $3(a)(1)$.					
19	9 (3) Critical supply chain.—The term "crit					
20	ical supply chain" means an end-to-end system tha					
21	converts raw materials into finished products in crit					
22	ical sectors, including in—					
23	(A) the defense industrial base;					
24	(B) the public health and biological pre					
25	paredness industrial base;					

1	(C) the information and communications
2	technology industrial base;
3	(D) the energy sector industrial base;
4	(E) the transportation industrial base; and
5	(F) agricultural supply chains.
6	(4) Critical supply chain resilience.—The
7	term "critical supply chain resilience" means miti-
8	gating gaps and vulnerabilities in critical supply
9	chains, including by—
10	(A) reducing risk of malicious sabotage or
11	external or internal manipulation; and
12	(B) improving the ability to withstand sup-
13	ply chain interruptions such as logistical chal-
14	lenges and workforce, materials, equipment, or
15	product shortages.
16	(5) Manufacturing and industrial innova-
17	TION.—The term "manufacturing and industrial in-
18	novation" means—
19	(A) providing assistance, resources, or
20	services to manufacturers or manufacturing
21	workers in the United States;
22	(B) offering expertise, improvements, re-
23	search, and development or other assistance in
24	technological innovations or advanced manufac-

1	turing in partnership with or for use by manu-
2	facturers in the United States; or
3	(C) developing policy that substantially im-
4	pacts the manufacturing sector in the United
5	States.
6	(6) Secretary.—The term "Secretary" means
7	the Secretary of Commerce.
8	SEC. 3. STUDY RELATING TO MANUFACTURING PROGRAMS
9	OF THE DEPARTMENT OF COMMERCE.
0	(a) Assessment.—Not later than 1 year after the
11	date of enactment of this Act, the Secretary shall produce
12	a report that—
13	(1) identifies offices and bureaus of the Depart-
14	ment of Commerce with responsibilities related to—
15	(A) critical supply chain resilience; and
16	(B) manufacturing and industrial innova-
17	tion;
18	(2) identifies the duties, responsibilities, pro-
19	grams, and expertise relevant to critical supply chain
20	resilience and manufacturing and industrial innova-
21	tion of each covered office and bureau;
22	(3) identifies and assesses the purpose, statu-
23	tory authority, effectiveness, efficiency, and limita-
24	tions of each covered office and bureau:

1	(4) identifies gaps between offices with duplica-						
2	tive duties, responsibilities, programs, and expertis						
3	within the Department of Commerce that are imple						
4	menting activities related to critical supply chain re-						
5	silience and manufacturing and industrial innova						
6	tion; and						
7	(5) provides recommendations to improve the						
8	effectiveness, efficiency, and impact of each covered						
9	office and bureau, including recommendations to—						
10	(A) optimize operations within or across						
11	covered offices and bureaus;						
12	(B) improve coordination across covered						
13	offices and bureaus; and						
14	(C) improve coordination with Federal						
15	agencies implementing similar activities related						
16	to critical supply chain resilience and manufac-						
17	turing and industrial innovation.						
18	(b) National Academy of Public Administra-						
19	TION.—The Secretary shall contract with the National						
20	Academy of Public Administration in producing the report						
21	under subsection (a).						
22	(c) Report.—Not later than 180 days after the date						
23	on which the Secretary produces the report under sub-						
24	section (a), the Secretary shall submit to the appropriate
