Illegitimate Court Counteraction Act—Cloture: By 54 yeas to 45 nays (Vote No. EX. 22), three-fifths of those Senators duly chosen and sworn, not having voted in the affirmative, Senate rejected the motion to close further debate on the motion to proceed to consideration of H.R. 23, to impose sanctions with respect to the International Criminal Court engaged in any effort to investigate, arrest, detain, or prosecute any protected person of the United States and its allies.
