We owe a profound debt of gratitude to Edward and all those of the Greatest Generation who sacrificed so much to secure the freedoms we cherish today. Let us ensure that their legacy endures, and their contributions are never forgotten.

IMPACT OF PRESIDENT TRUMP'S DISASTEROUS TARIFFS ON CANADA

Ms. MCCOLLUM. Mr. Speaker, in the last election, then-candidate Trump ran on lowering costs for American families. He owned the issue on the campaign trail, and he won. I had hoped that he would follow through on his promise to "lower costs on day one." But instead of working to lower costs, the President has waged an unprompted trade war with Canada that will cost Americans when they heat their homes, feed their families, run their small businesses, or tend to their farm.

It's been one week since President Trump imposed twenty-five percent tariffs on Canada. In retaliation, Ontario imposed a twenty-five percent surcharge on electricity exported to Minnesota, Michigan, and New York. This will directly impact Minnesotans' energy bills. Minnesotans and consumers across this country will feel the impact of Trump's tariffs at the grocery stores when they buy products like pork, produce, or eggs.

With the uncertainty of Trump's tariffs, small business owners aren't able to plan ahead for their businesses. Trump has small business owners on a rollercoaster, trying to predict the extra costs they will pay in this escalating trade war. Last week, my office met with Traci Tapani, a Co-President of Wyoming Machine, a small family-owned sheet metal fabricator in Stacy, MN who relies on Canadian aluminum for their operations. The past few weeks have been filled with uncertainty for their business, not knowing if Trump would roll back or increase the tariffs. And just today, Trump imposed additional tariffs imported aluminum, bringing the total tariffs on Canadian aluminum up to fifty percent. This will force small businesses like Wyoming Machine to adjust their operations once again. Trump isn't hurting Canada or Ontario with this trade war. He is hurting small business owners.

Trump's tariffs are also hurting farmers across this country who will incur greater costs when purchasing potash, a soil fertilizer often imported from Canada. And by inciting these trade wars, Trump is cutting off essential export markets for our farmers.

Americans know these tariffs are going to hit us hard. Our financial markets are in free fall because Americans fear this trade war will push us into a recession. Dr. John Spry, an economist at the University of St. Thomas, has estimated that as long as the Trump tariffs are in place, Americans will spend one-hundred dollars more on everyday goods each month. In my district, I'm hearing that working families and seniors on fixed incomes need relief from the high cost of living. They can't afford to add money for tariffs to their already tight monthly budgets.

Not only are the President's tariffs hurting my constituents, but he is also damaging our relationship with Canada: an ally, a partner, and for many—a good neighbor. Other than oil and electricity, Canada imports more goods from the United States than we import from Canada. They are our best customer, and we should not alienate our best customer. I'm a former social studies teacher. I know that tariffs can be a useful tool. But these tariffs on Canada are unprompted, unnecessary, and make no sense at all.

As a Minnesotan, the only thing I want to fight with Canadians about is who has the better hockey team and who can catch the most fish in the others' waters.

She enjoys intersecting her research with the arts and the humanities through dance performances and museum installations. She has been named among the top innovators in virtual reality and one of the top three greatest women visionaries in VR. She is the first person inducted into the National Academy of Engineering for immersive technologies and virtual reality, she is a member of the IEEE VR Academy, an IEEE Fellow,

an ACM Computer Pioneer, an AWE XR Hall of Fame member, and a Modeling and Simulation Hall of Famer. She received the IEEE VR Achievement Award and the International Digital Media & Arts Society Distinguished Career Award, among many national and international recognitions. She serves on national and international technology boards as well as government technology advisory committees. Her life's work addressing large problems through interdisciplinary teams has become a key to innovation and is considered standard practice in driving American competitiveness in the global economy.

Beyond its role as a historical archive, the San Elizario Veterans Memorial Museum plays an integral role in organizing veteran recognition events—including the Annual Veterans Day Parade and Ceremony, the Memorial Brick Walk, and the Honor Salute.

There is much work to do to end the pay gap. This bill represents a crucial step towards that goal. I urge my colleagues to support this bill.

SAVING NEMO ACT

Mr. CASE. Mr. Speaker, I rise today to urge support for my Saving Natural Ecosystems and Marine Organisms (NEMO) Act to protect the ornamental reef species living in the fragile and invaluable ecosystems of our world's endangered coral reefs.

Our oceans, teeming with life and rich biodiversity, depend on the health of coral reefs, some of the most biologically diverse ecosystems on Earth. Nearly 25 percent of the ocean's fish rely on coral reefs for shelter, food and breeding grounds. These reefs and

the species that inhabit them are critical to the balance and vitality of our oceans.

Unfortunately, coral reefs and the marine life living in them are under threat due to the high demand for ornamental reef species. This has resulted in unsustainable and harmful collection practices, such as overcollection of species, particularly younger specimens; reef dredging; the use of harmful gill nets, explosives, or poisons; and excessive mortality of specimens during transit.

These practices not only deplete species populations but also cause irreversible damage to the coral ecosystems themselves. In some cases, this damage has led to the extirpation of species from specific areas and the introduction of invasive species, which further disrupts the ecological balance. The long-term consequences of these practices are the loss of biodiversity and the degradation of habitats that are vital to the health of our oceans.

Many of these harmful collection practices occur in international waters, particularly in regions such as Southeast Asia, where most of the world's coral reefs are located. In many of these countries, there are weak or insufficient regulations to prevent destructive collection methods. As the largest importer of ornamental reef fish and corals, the United States bears a significant responsibility in perpetuating the demand for these species, which drives destructive practices in coral reef ecosystems worldwide.

We have an opportunity to take decisive action. My Saving NEMO Act would prohibit the importation into the United States of protected reef species taken through unsustainable or destructive practices. Going beyond complementing the Lacey Act, CITES and the Endangered Species Act, my bill will also fill a critical gap by addressing those species that, while not endangered, are still collected through methods that harm marine ecosystems. It also includes a process for delisting a species if the Secretary of the Interior and the Secretary of Commerce determine that its collection no longer poses a substantial risk to its sustainability, providing an incentive for the industry to adopt responsible practices.

Furthermore, the Saving NEMO Act would support industries that focus on sustainability and environmentally friendly practices, which is the future of the industry. In doing so, this bill will ensure that the aquarium trade evolves in a way that protects our oceans and promotes long-term ecological balance.

I urge my colleagues to support this critical legislation to help safeguard our coral reefs and the diverse marine life they support. By restricting the importation of ornamental reef species collected through harmful practices, we can protect these vital ecosystems for future generations.

Pablo later became a political activist. He was proud of having marched with labor leader Cesar Chavez, and he worked with local politicians and various community organizations. He was admired by elected leaders for his activism and knowledge of city politics in Hawthorne and surrounding communities. This led to Pablo being hired as a District Representative for both California State Senators Teresa Hughes and Edward Vincent.

A pillar of the community, Pablo was supportive of and served on the board of several organizations in Hawthorne, which included Moneta Gardens Improvement, Behavioral Health Services, Hawthorne Lions Club, and the Hawthorne Moose Lodge 1746, just to name a few.

In 2001, Pablo Cataño was elected to the Hawthorne City Council, becoming the first Chicano/Latino elected official in the city. His leadership was recognized when he assumed the role of mayor pro tempore, and after serving two terms on the city council, he retired in 2009 to focus on his health following a stroke.

Pablo Hernandez Cataño passed away on November 3, 2024, leaving behind to cherish his memory, his daughters Sylvia and Cynthia, grandchildren, great-grandchildren, nieces and nephews, and many close friends. On March 20, 2025, I will join Pablo's family, friends, and the entire Hawthorne community when the City of Hawthorne hosts a celebration of life for a great public servant, a devoted family man, and my friend, the Honorable Pablo Cataño.

My home state of Tennessee is known for many things. If you had to list some of the most prominent, you might think of the Great Smoky Mountains of Elvis Presley, but you would most certainly include the Grand Ole Opry.

Nashville is known around the world as Music City USA. That would not be the case had it not been for the Opry. But the longtime show isn't exclusive to Tennessee's story. No, it's part of American culture.

The Opry was around before the Great Depression and World War II. It has seen a lot, endured a lot, and served as a beacon of hope decade after decade.

The program's venue has moved within Nashville a few times, but it is primarily known for two locations the Ryman Auditorium off Broadway and its current location on Opry Mills Drive. Both locations enjoy hundreds of thousands of visitors every year.

Without the Grand Ole Opry, we would likely not know the names Hank Williams, Patsy Cline, Loretta Lynn, or Willie Nelson. Heaven forbid, we might not even know Dolly Parton had it not been for the show.

WSM, those are its call letters, was one of the first radio stations to connect urban and rural culture. The Opry was also a first to transform a hobby into a marketable and lucrative industry.

Crossover artists are not uncommon today. But they were virtually nonexistent before 1925. The Opry hosted honky-tonk, bluegrass, gospel, and rockabilly performers. This paved the way for what we know today as country music.

From music legends to up-and-comers, musicians around the world rightfully revere the Grand Ole Opry as a place of prestige, history, and continued relevance.

There are fewer than 100 members of the Grand Ole Opry. It is indeed an elite crowd of men and women who made the world better, who embody country music, and who are part of our shared heritage as Americans. In fact, that membership sits at the top of dozens of obituaries among some of our nation's finest performers.

This year, TripAdvisor ranked Nashville 6th among the best American travel destinations.

More than 17 million people visited last year. That is in large part because of the influence of the Grand Ole Opry over the last 100 years.

Mr. Speaker, any seat in the house will do at the Grand Ole Opry. To bear witness to the iconic barn background behind the stage, the lights that look like stars above you, and the acoustics around you makes for an unforgettable evening. No matter how many chances I get to see a show in person, I always sense the history, the importance, and the joy that the Grand Ole Opry represents.

As the United States Representative of Tennessee's 6th Congressional District, I rise today to enthusiastically congratulate the Grand Ole Opry on a century of entertainment and a century of significance. I am confident the man or woman in my shoes 100 years from now will feel compelled to do the same.

EXPOSING BIDEN LAWFARE PERSECUTION

Mr. WILSON of South Carolina. Mr. Speaker, I am grateful to former Congressman Bob Livingston for courageously exposing the shocking mistakes and abusive lawfare of former Attorney General, Merrick Garland. Innocent Americans have been persecuted by the subversion of the Justice Department under the Biden Administration, beginning with the deranged, maniacal persecution of President Donald Trump.

Under the Republican trifecta of the House, Senate, and Presidency, the Department of Justice and the Federal Bureau of Investigation will work on behalf of the people, not against them. American families can trust Attorney General Pam Bondi and FBI Director Kash Patel, both with proven records of professional competence.

I include in the RECORD the following letter below, written by Bob Livingston to the Wall Street Journal, regarding his own experiences with former Attorney General, Merrick Garland and the Justice Department:

"Dear Mr. Attorney General, Your time in office won't run out a moment too soon. You will be remembered as a tool in the Democratic Party's strategy of misusing the Justice Department to visit injustice on innocent people with differing political views. I am a victim of your dysfunctional leadership, but unlike many of your targets, I have survived unscathed.

I am 81. At the outset of my career, I enlisted in the U.S. Navy and sewed on active duty for two years, followed by an additional four in the reserves. When I returned to civilian life, I completed my undergraduate studies and law school. After some years of private practice, I successfully served as a prosecutor in three separate government offices.

I was then elected to Congress, where I served for 22 years. Shortly thereafter I created and ran the Livingston Group, a lobbying firm. For 25 years we represented defense, education, energy, health and corporate clients of all kinds. We also represented international clients, private and sovereign, but only if we were assured their interests coincided with those of the U.S.

In 2022 two Federal Bureau of Investigation agents came to my home in New Orleans and

questioned me about incidents involving our representation of an international client in 2018. Having nothing to hide, I spoke with them for 2½ hours.

I told them everything I could remember. I told them the truth. They quibbled with me about facts and reminded me of incidents that for whatever reason I couldn't recall. I have been interviewed by FBI agents in the past about varying matters under investigation, never about me, and I thought this no different. I was given to believe that they were looking only for background information.

At the end of the interview, the agents presented me with a search warrant for all my company's records related to their questions. As the lead agent left, she thanked me for my service to the country. But as I read the search warrant, I realized that this meeting was neither benign nor simply for background. The next day, with my wife listening, I called the agent and asked directly: "Am I a target?" To my great shock, the agent said yes.

In all my years as a lobbyist, I have bent over backward to comply with the Foreign Agents Registration Act. My company has always filed reports pursuant to the law when we thought they were due. I have repeatedly told my clients that we must comply with FARA to avoid any possibility of transgressing the law. The company has employed a full-time officer to assure compliance.

Yet Justice Department prosecutors said on several occasions that I was the target of felony charges. Every day and night for 20 months, I lived with the possibility that the hammer could drop at any moment. Everything I worked for would be tarnished. My firm would collapse, my employees would lose their jobs, all of us would be ruined in the press, and I could go to prison.

The conduct of law enforcement was torturous. In January 2024, a prosecutor interviewed a member of my staff, using curse words and accusing her of lying. In December 2023 an FBI agent harassed our FARA compliance officer, David Lonie, who had been a congressional staffer on the House Rules Committee before working with us for many years.

Lonie was an honorable and decent man, the epitome of integrity and honor. The agent nevertheless told him that if he knew what was good for him, he would talk. Dave was scared to death. He went to bed on Dec. 31, 2023, and didn't wake the next day. His family is devastated.

My company and I were innocent of all charges, and while I am pleased this Kafkaesque harassment is over, I am not content to simply shrug my shoulders and move on. We spent incredible amounts of money on legal counsel, more than three times what we earned by representing the client at issue. Our attorneys prepared an 88-page brief rebutting all charges. They succeeded in backing prosecutors down, but I am convinced the department's actions were political and malicious, targeting me as a lobbyist who has supported Donald Trump and been critical of President Biden.

Under your leadership, Mr. Garland, the Justice Department has been guilty of lopsided enforcement. Hunter Biden was nearly given a sweetheart immunity deal following receipt of millions of dollars from foreign sources for which he didn't file income tax returns or acknowledge his probable obligations under FARA. He was subsequently convicted for only a few of his crimes but has now been given a blanket pardon by his father. Members of the Trump administration and Mr. Trump himself have been hounded and arrested. They've had their lives ruined for minor white-collar infractions. Mr.

Trump has prevailed over attempts to destroy him, but others have been less fortunate.

As for our case, as we detailed in our brief, a Democratic firm wasn't as compliant regarding similar facts over a much longer period and to my knowledge was never investigated. If we had been charged and tried for six-year-old incidents despite our constant efforts to comply with the law, our case would have become additional evidence that you have led a department that has overtly ignored its obligation to provide justice.

The statute of limitations expired on our case in November, and prosecutors have said they are no longer interested in pursuing charges. That's nice but hardly satisfactory. As a matter of justice, Mr. Garland, you owe us and the American people a profuse apology."
