H.R. 3614. A bill to establish fair labor standards, occupational safety protections, and post-incarceration career opportunities for incarcerated individuals engaged in fire-fighting and to provide previously incarcerated firefighters an opportunity to expunge records of disposition after successful completion of court-imposed probation, and for other purposes; to the Committee on Education and Workforce, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

By Mr. TORRES of New York:

H.R. 3615. A bill to prohibit the obligation or expenditure of Federal funds to pay foreign governments and entities for the detention of certain individuals; to the Committee on the Judiciary.

#### CONSTITUTIONAL AUTHORITY STATEMENT

Pursuant to clause 7 of rule XII of the Rules of the House of Representatives, the following statements are submitted regarding the specific powers granted to Congress in the Constitution to enact the accompanying bill or joint resolution.

By Ms. KAMLAGER-DOVE:

H.R. 3614

Congress has the power to enact this legislation pursuant to the following:

This bill is introduced pursuant to the powers granted to Congress under the General Welfare Clause (Art. 1 Sec. 8 Cl. 1), the Commerce Clause (Art. 1 Sec. 8 Cl. 3), and the Necessary and Proper Clause (Art. 1 Sec. 8 Cl. 18). Further, this statement of constitutional authority is made for the sole purpose

of compliance with clause 7 of Rule XII of the Rules of the House of Representatives and shall have no bearing on judicial review of the accompanying bill.

By Mr. TORRES of New York:

H.R. 3615

Congress has the power to enact this legislation pursuant to the following:

Article 1, Section 8
