Dear Chairman Walberg and Ranking Member Scott,

The October 7, 2023 Hamas attack caused a tectonic shift for Berkeley's Jewish students, staff and faculty, from many perspectives. In the face of a turbulent outside world, we commend the UC Berkeley administration, including the Chancellor and other campus leaders, for keeping our campus functioning: teaching and research were not hindered, protests were confined, and the UC Berkeley administration made significant and impactful efforts to ensure that Jewish students, staff, and faculty were safe on campus and felt accepted and integral to the university community.

We also commend the UC Berkeley campus leadership for listening and responding when we voiced concerns and criticisms, for negotiating a peaceful end to the encampment, for working to enforce rules while maintaining the right to free speech, for committing additional and significant resources to ensure safety and security of the Campus community including Jewish students, staff and faculty. Moreover, the UC Berkeley administration continues to support the many ways in which there has been a renewal of Jewish campus life, including through Jewish student organizations, Jewish studies, Israel studies, and antisemitism education.

Chancellor Carol Christ and her successor in July 2024, Chancellor Richard Lyons, and the campus senior leadership team continue to work closely with the members of the Chancellor's Advisory Committee on Jewish Student Life and Campus Climate. The input and guidance provided by this Committee have informed campus actions in support of the needs and interests of Jewish students, faculty, and staff. While we don't always agree with the administration's decisions, it is abundantly clear to us that, overall, the campus administration has a long-standing commitment to combat antisemitism on our campus.

This letter does not dismiss the real challenges Jewish students, staff, and faculty have faced, including moments of unease and, at times, physical threats. Incidents of hostile speech and even isolated acts of violence have occurred. However, as Jewish faculty who frequently engage with campus leadership and remain vigilant about the well-being of the Jewish campus community, we reject the claim that UC Berkeley is an antisemitic environment. We write to affirm that we feel secure on campus and support the administration's efforts to balance safety with respect for free speech.

We are aware that important areas for improvement remain. There are ongoing and productive discussions with the Chancellor and other senior administrators regarding ways to increase communication, accountability, and education about antisemitism on campus. We are committed to continuing to work in partnership with the UC Berkeley Chancellor and senior leadership to continue to ensure that UC Berkeley does not tolerate antisemitic harassment or discrimination and to continue to ensure the safety, security, engagement and productivity of UC Berkeley Jewish students, staff and faculty.
