

Directs the development, coordination, implementation and leveraging of a broad range of programs and capabilities addressing diverse threats to the U.S. and world agricultural economies and food supply. Serves as the liaison between NABC and national, state, and local stakeholders and allied industry groups. Serves as Associate Director of the KSU Biosecurity Research Institute. Adjunct faculty appointment in the Department of Diagnostic Medicine and Pathobiology, College of Veterinary Medicine.

**Exercise Crimson Winter**, January 10, 2003. A bioterrorism simulation for the Food Safety and Inspection Service (FSIS), U.S. Department of Agriculture.

**Operation Winter Sun**, May 18, 2003. A chemical weapons full-scale exercise for New York City.

Exercise High Stakes, June 19, 2003. A state-level agrosecurity exercise for the state of Kansas.

**Oktoberfest: State of Kansas Hospital Bioterrorism Program**, October 2003. A facilitated exercise workshop to explore existing resources and the medical response infrastructure identified through Kansas regional hospital plans

Exercise Sudden Impact, January 29, 2004. A combined state-county level zoonotic agrosecurity exercise in Ford County Kansas.

**Exercise High Plains Guardian**, July 30-31, 2004. A state-level agrosecurity exercise to explore civilian and military interactions.

Exercise Endangered Species, October 6, 2004. A combined state-county level exercise addressing analysis of agrosecurity threat information in Reno County Kansas.

**Vigilant Guard,** March 13-15, 2006. The exercise, sponsored by the Joint National Guard Bureau's (JNGB's) J7 Office, was designed to enhance the preparedness of state National Guard organizations in performing roles and responsibilities associated with homeland defense and Defense Support to Civil Authorities (DSCA). The *Vigilant Guard* exercise was hosted by the Kansas National Guard (KSNG).

Wolf Creek Nuclear Generating Station, October 18-19, 2007. The Department of Homeland Security (DHS)/Federal Emergency Management Agency (FEMA), Region VII, conducted an exercise in the plume and ingestion exposure pathway emergency planning zone (EPZ/IPZ) around the Wolf Creek Nuclear Generating Station.

Vigilant Guard 2009 Region VII, June 18, 2009. The exercise, sponsored by United States Northern Command and North American Air Defense (N-NC), was designed to enhance the preparedness of state National Guard organizations in performing roles and responsibilities associated with homeland defense and Defense Support to Civil Authorities (DSCA). The event exercised the Kansas Foreign Animal Disease Response Plan.

**SAMS/KO**, October 22, 2009. Stop Animal Movement Statewide, Kansas-Oklahoma, sponsored by the Multi-State Partnership for Security in Agriculture with funding from DHS Office of Grants and Training, provided a functional exercise for the Kansas and Oklahoma EOC's and a full-scale exercise at a cross-border location to examine the ability to stop animal movement.

**RIPSTOP 2013**, October 9-10, 2013. This Kansas Department of Agriculture functional exercise presented a real-life scenario that would cause a state and local response and looked directly at Kansas State University's response to a FAD on campus.

- **INVISIBLE FIRE**, September 24, 2014. This Kansas Department of Agriculture regional exercise tested the ability of North Central region counties in Kansas to execute movement control activities during a FAD response.
- **AFTERBURN**, December 19-22, 2016. This Kansas Department of Agriculture statewide exercise tested the ability of local, state, and Federal response entities to communicate and coordinate activities and decisions during a FAD response.
- **PHOENIX**, December 18-20, 2017. This Kansas Department of Agriculture statewide exercise tested the ability of multiple local, state, and Federal response entities to communicate and coordinate activities and decisions during a FAD response.
- **RAMPART**, December 17-20, 2018. This Kansas Department of Agriculture statewide exercise tested the ability of multiple local, state, and Federal response entities to communicate and coordinate activities during a FAD response with particular attention to Safe Food Supply plans and resumption of marketing.
- **SFEAR,** September 23-26, 2019 This USDA/NAHLN exercise tested the ability of 14 states and their local, state and Federal partner to coordinate and communicate key areas of an African Swine Fever response and mitigation.
- **FORTIFY**, December 16-18, 2019. This Kansas Department of Agriculture statewide exercise tested the ability of local, state, and Federal response entities to implement a stop movement order and conduct multiple field investigations across the state.
- **KSU VDL**, May 20, 2021. This KSU Veterinary Diagnostic Laboratory tabletop exercise tested the ability of KSVDL, Kansas Department of Agriculture, Biosecurity Research Institute, and members of the NAHLN network to coordinate and communicate the ability to surge test for ASF.
- **KSU Infrastructure TTX**, October 7, 2021. This exercise tested Kansas State University's ability to response, communication, preparedness, and awareness to a FAD identified on campus.
- **ARMOR**, December 13-15, 2021. This Kansas Department of Agriculture statewide exercise tested the ability of local, state, and Federal response entities, specifically with direction at the initial state response to a FAD within the state, vaccination requesting and planning, and surveillance activities.
- **KSU VDL**, January 24-25, 2022. This KSU Veterinary Diagnostic Laboratory exercise tested the ability to complete surge testing at the Biosecurity Research Institute. Staffing, testing, and surge capacity testing capabilities for ASF were functionally practiced and recorded based off of the previous 2021 tabletop exercise.

**GENESIS**, December 12-14, 2022. This Kansas Department of Agriculture statewide exercise tested the ability of local, state, and Federal response entities, specifically with direction at the initial state response to a FAD within the state and surveillance activities.

**PATHWAYS**, December 1-3, 2023. This Kansas Department of Agriculture statewide exercise tested the ability of local, state, and Federal response entities to maintain a common operating picture, coordinate communication, and ensure there was a unified structure with all response partners during an escalating outbreak of FMD from one state to multiple states.

**WATCHTOWER**, December 17 - 19, 2024. This Kansas Department of Agriculture statewide exercise tested the ability of local, state, and Federal response entities to communicate and coordinate activities and decisions during a FAD response.
