

AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H.R. 2306
OFFERED BY MR. WESTERMAN OF ARKANSAS

Strike all after the enacting clause and insert the following:

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the “The Adams Memorial-
3 Great American Heroes Act”.

4 SEC. 2. EXTENSION OF AUTHORITY; LOCATION OF MEMO-
5 RIAL.

6 (a) ADAMS MEMORIAL COMMISSION.—Section
7 2406(l) of the John D. Dingell, Jr. Conservation, Manage-
8 ment, and Recreation Act (Public Law 116–9) is amended
9 by striking “2025” and inserting “2032”.

10 (b) COMPLIANCE WITH STANDARDS FOR COMMEMO-
11 RATIVE WORKS.—Section 1(c) of Public Law 107–62 (115
12 Stat. 411; 124 Stat. 1192; 127 Stat. 3880; 133 Stat. 750)
13 is amended—

14 (1) by striking “The establishment” and insert-
15 ing “Notwithstanding section 8908(c) of title 40,
16 United States Code, the establishment”; and

17 (2) by striking “2025” and inserting “2032”.

1 (c) LOCATION OF COMMEMORATIVE WORK.—Section
2 1 of Public Law 107–315 (116 Stat. 2763) is amended
3 to read as follows:

4 **“SEC. 1. APPROVAL OF COMMEMORATIVE WORK.**

5 “(a) SITE.—Notwithstanding section 8908(c) of title
6 40, United States Code, and subject to subsection (b), the
7 Adams Memorial shall be located within the area generally
8 depicted as ‘Adams Memorial: Eligible Additional Area’ on
9 the map titled ‘Adams Memorial: Eligible Additional Area’
10 prepared by the Adams Memorial Commission and dated
11 February 25, 2025.

12 “(b) ADDITIONAL LOCATIONS.—If the Commission
13 determines that the location described in subsection (a)
14 is not suitable or feasible due to physical or security con-
15 straints, the commemorative work shall be located within
16 the Reserve.

17 “(c) DEFINITIONS.—In this section:

18 “(1) ADAMS MEMORIAL.—The term ‘Adams
19 Memorial’ means the commemorative work author-
20 ized to be established under section 1(b) of Public
21 Law 107–62 (115 Stat. 411).

22 “(2) COMMISSION.—The term ‘Commission’
23 means the Adams Memorial Commission established
24 under section 2406(a) of the John D. Dingell, Jr.

1 Conservation, Management, and Recreation Act
2 (Public Law 116–9).

3 “(3) RESERVE.—The term ‘Reserve’ has the
4 meaning given such term in section 8902(a)(3) of
5 title 40, United States Code.

6 “(d) CONFORMING AMENDMENTS.—Section 2 and
7 section 3 of Public Law 107–315 (116 Stat. 2763) are
8 hereby repealed.”.
