H.R. 889, making supplemental appropriations and rescissions for the fiscal year ending September 30, 1995. Signed April 10, 1995. (P.L. 104-6)

H.R. 831, to amend the Internal Revenue Code of 1986 to permanently extend the deduction for the health insurance costs of self-employed individuals, and to repeal the provision permitting nonrecognition of gain on sales and exchanges effectuating policies of the Federal Communications Commission. Signed April 11, 1995. (P.L. 104-7)

H.R. 1345, to eliminate budget deficits and management inefficiencies in the government of the District of Columbia through the establishment of the District of Columbia Financial Responsibility and Management Assistance Authority. Signed April 17, 1995. (P.L. 104-8)

S. 178, to amend the Commodity Exchange Act to extend the authorization for the Commodity Futures Trading Commission. Signed April 21, 1995. (P.L. 104-9)
