

MISCELLANEOUS MEASURES; BUDGET VIEWS AND ESTIMATES

Committee on the Judiciary: Ordered reported the following bills: H.R. 809, Antitrust Technical Corrections Act of 2001; S. 320, as amended, Intellectual Property and High Technology Technical Amendments Act of 2001; H.R. 802, Public Safety Officer Medal of Valor Act of 2001; H.R. 741, to amend the Trademark Act of 1946 to provide for the registration and protection of trademarks used in commerce, in order to carry out provisions of certain international conventions; H.R. 860, Multidistrict, Multiforum Trial Jurisdiction Act of 2001; and H.R. 861, to make technical amendments to section 10 of title 9, United States Code.

The Committee approved, as amended, Budget Views and Estimates on the Fiscal Year 2002 Budget for submission to the Committee on the Budget.

CONSEQUENCES FOR JUVENILE OFFENDERS ACT

Committee on the Judiciary: Subcommittee on Crime held a hearing on H.R. 863, Consequences for Juvenile Offenders Act of 2001. Testimony was heard from Michael J. NATIONAL FIRE PLAN IMPLEMENTATION

Committee on Resources: Subcommittee on Forests and Forest Health held a hearing on the National Fire Plan Implementation.
