Committee on Resources: Ordered reported the following bills: H.R. 107, amended, to require that the Secretary of the Interior conduct a study to identify sites and resources, to recommend alternatives for commemorating and interpreting the Cold War; H.R. 1161, amended, to authorize the Government of the Czech Republic to establish a memorial to honor Tomas G. Masaryk in the District of Columbia; H.R. 1230, amended, Detroit River International Wildlife Refuge Establishment Act; H.R. 1384, amended, Navajo Long Walk National Historic Trail Study Act; H.R. 1456, Booker T. Washington National Monument Boundary Adjustment Act of 2001; H.R. 1814, amended, Metacomet-Monadnock-Sunapee-Mattabesett Trail Study Act of 2001; H.R. 1989, amended, Fisheries Conservation Act of 2001; H.R. 2062, amended, to extend the effective period of the consent of Congress to the interstate compact relating to the restoration of Atlantic salmon to the Connecticut River Basin and creating the Connecticut River Atlantic Salmon Commission; and H.R. 2385, amended, Virgin River Dinosaur Footprint Preserve Act.

SAME DAY CONSIDERATION OF CERTAIN RESOLUTIONS REPORTED BY THE COMMITTEE ON RULES

Committee on Rules: Granted, by voice vote, a resolution waiving clause 6(a) of rule XIII (requiring a

two-thirds vote to consider a rule on the same day it is reported from the Rules Committee) against certain resolutions reported from the Rules Committee. The resolution applies the waiver to a special rule reported on the legislative day of Thursday, September 13, 2001, providing for consideration or disposition of a bill making emergency supplemental appropriations for the fiscal year 2001 for additional disaster assistance, for anti-terrorism initiatives, for assistance in the recovery from the tragedy that occurred on September 11, 2001, and for other purposes, any amendment thereto, any conference report thereon, or any amendment reported in disagreement from a conference thereon.
