Committee on Foreign Affairs: Subcommittee on International Organizations, Human Rights and Oversight and the Subcommittee on Higher Education, Lifelong Learning and Competitiveness of the Committee on Education and Labor held a joint hearing on International Students and Visiting Scholars: Trends, Barriers, and Implications for American Universities and U.S. Foreign Policy. Committee on Veterans' Affairs: Subcommittee on Economic Opportunity approved for full Committee action the following bills: H.R. 1315, To amend title 38, United States Code, to provide specially adaptive housing assistance to certain disabled members of the Armed Forces residing temporarily in housing owned by a family member; H.R. 1750, amended, To amend the Servicemembers Civil Relief Act to extend from 90 days to 1 year the period after release of a member of the Armed Forces from active duty during which the member is protected from mortgage foreclosure under that Act; H.R. 1240, amended, To direct the Secretary of Veterans Affairs to establish a scholarship program for students seeking a degree or certificate in the areas of visual impairment and orientation and mobility; and H.R. 1632, amended, Improving Veterans' Reemployment Act of 2007.
