Rejected:

By 34 yeas to 65 nays (Vote No. 13), McCain (for Grassley/Hatch) Amendment No. 14, in the nature of a substitute. **Page S511**

A unanimous-consent-time agreement was reached providing that the following amendments be the only first-degree amendments in order to the bill: Leahy Amendment No. 21; Portman Amendment No. 10; Murkowski Amendment No. 11; Coburn Amendment No. 13; Coburn Amendment No. 15; and Coburn Amendment No. 16; that there be no amendments in order to any of the amendments in

this list prior to votes on or in relation to the amendments; that when the Senate resumes consideration of the bill following any Leader remarks on Monday, February 11, 2013, the time until 5:30 p.m., be equally divided between the two Leaders, or their designees, prior to votes on or in relation to the remaining amendments and passage of the underlying bill, as amended, if amended; that Senator Cornyn have 45 minutes under his control on the Republican side; and that there be two minutes equally divided prior to each vote. **Page S510**
