**Boko Haram:** Senate passed S. 1632, to require a regional strategy to address the threat posed by Boko Haram, after agreeing to the committee amendment in the nature of a substitute, and the following amendment proposed thereto: **Pages S6905–06**

McConnell (for Lankford/Inhofe) Amendment No. 2677, to require that the Director of National Intelligence assess the capability of the United States Government to help implement the 5-year strategy to counter the regional threat of Boko Haram. **Page S6905**

**Albuquerque Indian School Land Transfer Act:** Senate passed S. 986, to require the Secretary of the Interior to take into trust 4 parcels of Federal land for the benefit of certain Indian Pueblos in the State of New Mexico. **Page S6906**

**Breast Cancer Research Stamp:** Senate passed S. 1170, to amend title 39, United States Code, to extend the authority of the United States Postal Service to issue a semipostal to raise funds for breast cancer research. **Pages S6906–07**

**National Retirement Security Week:** Senate agreed to S. Res. 263, supporting the goals and ideals of National Retirement Security Week, including raising public awareness of the various tax-preferred retirement vehicles, increasing personal financial literacy, and engaging the people of the United States on the keys to success in achieving and maintaining retirement security throughout their lifetimes. **Page S6907**

**National Falls Prevention Awareness Day:** Senate agreed to S. Res. 264, designating September 23, 2015, as “National Falls Prevention Awareness Day” to raise awareness and encourage the prevention of falls among older adults. **Page S6907**

**Honoring Congressman Louis Stokes:** Senate agreed to S. Res. 265, honoring the life, accomplishments, and legacy of Congressman Louis Stokes. **Page S6907**

#### Measures Considered:

**Pain-Capable Unborn Child Protection Act:** Senate continued consideration of the motion to proceed to consideration of H.R. 36, to amend title 18, United States Code, to protect pain-capable unborn children. **Pages S6860–64, S6868**

During consideration of this measure today, Senate also took the following action:

By 54 yeas to 42 nays (Vote No. 268), three-fifths of those Senators duly chosen and sworn, not having voted in the affirmative, Senate rejected the motion to close further debate on the motion to proceed to consideration of the bill. **Page S6864**

Subsequently, the motion to proceed was withdrawn. **Page S6868**

**Department of Defense Appropriations Act:** By 54 yeas to 42 nays (Vote No. 269), three-fifths of those Senators duly chosen and sworn, not having voted in the affirmative, Senate upon reconsideration rejected the motion to close further debate on the motion to proceed to consideration of H.R. 2685, making appropriations for the Department of Defense for the fiscal year ending September 30, 2016. **Page S6864**
