Res. 61, relating to fiscal matters to limit appropriations not to exceed budget estimates, except in time of war or by three-fifths vote of each House; and Senator Langer, on behalf of himself and Senator Taylor, on S. J. Res. 106, relating to term of office of the President and providing for his popular election.
