Committee on Ways and Means: Completed review of draft of legislation embodying recommendations of the Subcommittee on Excise Tax Technical and Administrative Problems and agreed that Representative Forand would introduce the bill as soon as it is ready so that it will be available to the public for comment during adjournment.

D. C. TRANSIT

Committee on Armed Services: Committee met in executive session to hear Air Force Chief of Staff Gen. Nathan F. Twining present an account of his recent visit to the Soviet Union.

COMMITTEE BUSINESS

Committee on Banking and Currency: Committee, in executive session, ordered favorably reported without amendment S. 3911, to amend the Federal Deposit Insurance Act to provide safeguards against bank mergers; and with amendment S. 3832, to provide for the dis-

posal of the Government-owned synthetic rubber research laboratories at Akron, Ohio, and S. 3868, to extend the life of the Export-Import Bank of Washington to June 30, 1963, from June 30, 1958 (amendment would require the bank to contribute its fair share toward the cost of the civil-service retirement and disability fund on the basis of billings by the Civil Service Commission, and the cost of the employees' compensation fund on the basis of billings by the Department of Labor).

Committee on Interior and Insular Affairs: Committee, in executive session, ordered favorably reported the following:

FOREIGN AIR TRANSPORTATION

Committee on Interstate and Foreign Commerce: Aviation Subcommittee held hearings on section 1 of S. 3914, to amend the Civil Aeronautics Act of 1938 regarding foreign air transportation. Testimony in opposition to this section of the bill was heard from Thorsten V. Kalijarvi, Deputy Assistant Secretary of State for Economic Affairs, and Louis S. Rothschild, Under Secretary of Commerce for Transportation.

JUVENILE DELINQUENCY

Committee on the Judiciary: The Subcommittee on Juvenile Delinquency held hearings to explore the possibility of using surplus military installations for Boys' Town-type projects. Testimony was heard regarding the possible use for such purposes of a portion of the naval air station at Squantum, Mass., from Gordon K. Hurd, chairman of the advisory committee, Boys Town of Massachusetts; Starr King, former superintendent of schools, Beverly, Mass.; Dr. Emil M. Hartl, director of the Charles Hayden Goodwill Inn for Boys of Morgan Memorial of Massachusetts; William Footit, Jr., police chief of Shutesbury, Mass.; and William H. Browne, acting probation officer of district court of western Hampden County, and trustee of Boys Town of Massachusetts, representing Hampden County, Mass.

AGRICULTURE

Committee on Agriculture: In executive session ordered favorably reported to the House the following bills:

H. R. 8384, to amend section 8c (2) of the Agricultural Marketing Agreement Act of 1937, as amended; and

H. J. Res. 642, to quitclaim certain property in Coahoma County, Miss.

The committee also approved various pending watershed projects.

MILITARY

Committee on Armed Services: Subcommittee on Acquisitions and Disposals considered 12 Air Force real-estate projects, recommending approval of 10 and withholding action on 2; also approved additional increment in the guarantee rental housing program overseas and recommended approval of several Capehart housing projects for the Air Force. Witnesses heard were Don Black, Real Estate Division, and Norman Dole, Housing Division, Department of the Air Force.

BRANDEIS MEDAL

Committee on Banking and Currency: In executive session ordered favorably reported to the House H. R. 11000, providing for the striking of medals in commemoration of the 100th anniversary of the birth of the late Justice Louis D. Brandeis. The committee also considered but took no final action on S. 3732, to provide insurance against flood damage.

AID TO BLIND

Committee on Education and Labor: Special subcommittee met on H. R. 3136 and H. R. 11754, to authorize wider distribution of books and other special instructional material for the blind, and to increase the appropriations authorized for this purpose. Witnesses heard were Representatives Robsion; Clarence P. Scandlebury, Special Assistant to Secretary, Health, Education, and Welfare; Edmund Baxter, HEW; Finis E. Davis, superintendent, American Printing House for the Blind; Kathern Gruber, assistant director, American Federation for the Blind; Dr. Lester N. Myer, National Association of State Directors of Special Education; and Mrs. Hazel McIntire, director, special education, Ohio State Department of Education.

CIVIL AVIATION

Committee on Government Operations: Subcommittee on Legal and Monetary Affairs continued hearings on Monday and Tuesday on the role of the Federal Government in civil aviation. Witnesses, all representing the CAA, were Charles J. Lowen, Administrator; Joseph Blatt, Director, Program Planning; David Thomas, Director, Air Traffic Control; J. H. Tippets, Director, Air Navigation Facilities; William Davis, Director, Aviation Safety; Herbert Howell, Director, Airports; and Robert P. Boyle, General Counsel.

GOVERNMENT INFORMATION

Committee on Government Operations: Subcommittee on Government Information continued hearings on the policies of Federal agencies in withholding information from the Congress and the public. Witnesses, all representing the Department of Defense, were Robert T. Ross, Assistant Secretary of Defense; Philip Allen, Deputy Assistant Secretary for Public Affairs; Leonard Niederlehner, Deputy General Counsel; and C. Herschell Schooley, Director, Public Information. Hearings continue on Thursday.

LAND CONVEYANCE

Committee on Government Operations: Subcommittee on Government Activities met in executive session and ordered favorably reported to the full committee the following bills:

S. 3316 (amended), conveying certain property to the city of Roseburg, Oreg.; and

S. 3195 (amended), conveying certain lands to the town of North Kingstown, R. I.

INTERIOR MISCELLANY

Committee on Interior and Insular Affairs: Ordered the following bills favorably reported to the House with amendment:

H. R. 10252, to amend the Organic Act of the Virgin Islands regarding appointment of marshal and deputy marshal;

H. R. 10183, to convey certain Indian tribal lands to the U. S.;

H. R. 8474, to quiet title to certain property in Alabama;

H. R. 7181, to provide that Mikveh Israel Cemetery in Philadelphia shall be a national shrine; and

H. R. 10371, to provide that withdrawals or reservations of more than 5,000 acres of public lands of the United States for certain purposes shall not become effective until approved by act of Congress.

The committee also ordered favorably reported to the House without amendment S. 2395, to exclude certain lands from Acadia National Park, Maine.

ANTITRUST

Committee on the Judiciary: Subcommittee No. 5 continued and concluded hearings on S. 3879 and H. R. 11360, to supplement the U. S. antitrust laws to enable

automobile dealers to bring suit against automobile manufacturers regarding termination of franchise. The following witnesses were heard: William Hufstadter, vice president in charge of sales, General Motors; Lloyd Halvorson, National Grange.

JUDICIARY

Committee on the Judiciary: In executive session ordered favorably reported to the House H. R. 8617 (amended to include provisions contained in H. R. 11125), to validate certain payments of sea-duty pay made to naval personnel serving on board vessels in the Great Lakes during the period November 1, 1950, to October 31, 1953.

PLEASURE BOATS

Committee on Merchant Marine and Fisheries: Held hearing to determine the necessity or desirability of additional Federal legislation to regulate pleasure boating in the United States. Testimony was received from Ralph G. Klieforth, president, National Association of Engine & Boat Manufacturers, accompanied by Wesley Wheeler, director, John Trumphy, Jr., vice president, Gordon Rule, counsel; and John B. Tanner, commodore, U. S. Coast Guard Auxiliary, San Diego, Calif.

RETIREMENT

Committee on Post Office and Civil Service: Resumed hearings on S. 2875, to revise the Civil Service Retirement Act. Witnesses heard were Russell R. Reagh, John P. Jones, member, Board of Actuaries; Joseph Campbell, Comptroller General; and Charles I. Schottland, Commissioner, Social Security Administration.

FLOOD CONTROL

Committee on Public Works: Subcommittee on Flood Control ordered favorably reported to the full committee the following bills:

H. R. 12093, reconveying certain lands acquired for reservoir projects located in State of Texas to former owners thereof; and

S. 2093 (amended), authorizing the granting of certain property damages as a result of construction of the Oahe, Gavins Point, and Fort Randall dams and reservoir projects, Missouri River.

SUPPLEMENTAL APPROPRIATION

Committee on Rules: Granted rule waiving points of order on H. R. 12138, supplemental appropriations for the fiscal year ending June 30, 1957. Representatives Taber and Mahon were heard in support of the rule.

STATES RIGHTS

Committee on Rules: Granted an open rule with 2 hours of debate on H. R. 3, establishing rules of interpretation governing questions of the effects of acts of Congress on State law. Representative Celler opposed the bill but favored a closed rule. Representative Keating testified in support of the rule and bill as amended.

SHIPPING

Committee on Rules: Concluded hearings but took no action on request of rule on H. R. 11122, to promote the development and rehabilitation of the coastwise trade and encourage the construction of new vessels. Supporting witnesses were Representatives Robeson, Allen of California, and Boykin; opposing the rule was Representative Zelenko.

CONSTRUCTION CONTRACTS

Committee on Rules: Continued but did not complete hearing on request of rule on S. 1644, to prescribe policy and procedure in connection with construction contracts made by executive agencies. Representatives Celler and Keating were heard in support of the rule.

BLACKLISTING

Committee on Un-American Activities: Heard John Cogley, director of a recently published survey by the Fund for the Republic on the subject of "blacklisting" of alleged or acknowledged Communists in the entertainment industry. Hearings continue on Wednesday.

WAYS AND MEANS COMMITTEE

Committee on Ways and Means: Authorized the establishment of the following subcommittees:

1. A subcommittee on internal revenue taxation for the purpose of investigating and studying the operation and effects of the internal revenue laws as to substantive policy, technical adequacy, and administration, and making recommendations with respect thereto.

2. A subcommittee on customs, tariffs, and reciprocal trade agreements, to conduct an investigation and study of all aspects of our customs, tariffs, and reciprocal trade agreements laws and the administration thereof.

It was agreed to broaden the jurisdiction of the existing Subcommittee on Excise Tax Technical and Ad-

ministrative Problems to include an overall study of excise taxes.

WAYS AND MEANS MISCELLANY

Committee on Ways and Means: In executive session ordered favorably reported to the House the following bills:

H. R. 10177, providing for the free importation of certain shoe lathes; and

H. R. 9396, providing for the duty-free importation of guar seed, was ordered favorably reported with technical amendments.

The committee also considered the following bills:

H. R. 10578, relating to the tax treatment of employee contributions to the railroad retirement fund was referred to the Subcommittee on Internal Revenue Taxation;

H. R. 11952, relating to the classification of corduroy in the Tariff Act of 1930, was passed over with the understanding that the interested executive departments would submit a further report within a week on the legislation; and

H. Res. 475, relating to the settlement of a tax case involving the American Distilling Co., was discussed and a memorandum relating to this case was being presented to the committee upon adjournment.

The committee will next meet at 10 a. m. on Thursday, July 12, 1956.
